# Basic Aims of the Programme

Basic aims of the first cycle programme Social Work are:

- 1. Provision of the quality education for the profession of social work.
- 2. Promotion of mobility for students and academic and administrative personnel.
- 3. Active participation in the Bologna process of the higher education institution, its teachers and students, and the participation of students in the educational process.
- 4. Promotion of the European dimension in higher education.

# General Competences (Learning Outcomes)

- 1. Knowledge and understanding of concepts, theories and phenomena as well as methods and procedures of social work. (For example: social contexts, legal norms, institutions, public policy and administration, human resources management...)
- 2. Ability to analyse and synthesise. (For example: analysis of social phenomena and developments; synthesis of knowledge from the field, ability to understand connections between individuals' problems and a wider social context, the ability to identify and eliminate systemic obstacles...)
- 3. Use of knowledge, procedures and methods. (For example: the use of knowledge and procedures of user empowerment, collaborative search and co-creation of support networks, co-creation of a working relationship, advocacy and inclusion of underprivileged people...; use of knowledge on structural characteristics of marginalisation, use of different sources of support and assistance; use of methodological research tools; use of modern approaches and principles, harmonisation of tasks and selection of methods and ways of work according to professional standards.)
- 4. Ability for strategic thinking and acting. (For example: the ability for team planning and evaluation, predicting the development of events, discrimination between what is essential and what is inessential, co-creation of sustainable solutions to basic problems, advocacy attitude...)

- 5. Critical and ethical (self)reflection in thinking and acting. (For example: commitment to professional ethics in a social environment through respecting the principle of non-discrimination and multiculturalism, the ability to reflect on one's own participation.)
- 6. Identification, understanding of and responding to diversity (For example: the ability to shed light on one's own prejudice and discriminatory actions, identification of racist and discriminatory actions and social ideologies and acting against them, flexible participation in different social and cultural environments; identification, written recording and documenting of personal stories of users /their problems, needs, aims, sources etc./, differences between them and responses to these.)
- 7. Identification and understanding of persons' distress and crises related to social and personal circumstances. (... in the life of individuals, families, groups, collectives, communities...)
- 8. The ability to co-create the desired outcomes through considering an individual's perspective. (The ability to monitor and manage circumstances such as the articulation of pending un-reflected upon conflicts, establishment of working relationship and personal contact, shaping a joint problem definition and the desired outcome, conducting the conversation progressing towards the desired outcomes, negotiating...)
- 9. Communication skills. (The ability of reporting, listening, summarising, writing, public presentation and argumentation, rhetoric abilities, the ability of clear, active, informed public presentation, use of information and communication technologies...)
- 10. Innovation. (The ability to (co)create original or different concepts, solutions, procedures instead of routine procedures that are ineffective in given circumstances.)
- 11. The ability for team, group and project work. (The will to co-operate, respect others' opinions and fulfil the agreed role within the team and group, the ability to collaborate and represent the views of the profession in an interdisciplinary environment...)
- 12. Networking ability. (For example: making connections within the organisation as well as outside it, management of formal and informal relations, skilled use of networks in the context of the problem under consideration...)
- 13. The ability of joint management and co-management. (For example: the abilities of coordination, organisation, counselling, management... together with users and professional peers.)
- 14. The ability to work in an international and plural professional environment. (For example, the ability to understand global processes, articulation and representation of the profession in an international environment, work in international professional bodies, writing and publishing in international publications...)
- 15. Professionalism: the ability to maintain professional discipline, care for one's own professional development, for the development, establishment and reputation of the profession and dissemination of knowledge.

#### Subject-specific Competence (Learning Outcomes)

- 1. Knowledge and ability of consistent use of the language of social work (SW).
- 2. The ability to co-create original projects of support and assistance in dialogue with the users and other participants in a concrete field of SW.
- 3. Understanding of the work of institutions and the improvement of institutional practices in a specific field of SW
- 4. Knowledge and understanding of the history of the development of professional concepts and practices in a specific field of SW.
- 5. Critical reading of professional languages (discursive or epistemological analysis) and their effects in a specific field of SW.
- 6. The ability to connect user experience with SW doctrine in original projects of support and assistance, so this will be efficient for the user.
- 7. Knowledge and skills to use professional methods and procedures in a specific field of SW.
- 8. Knowledge and ability to use the contribution of other professions relevant for SW (sociology, psychology, anthropology, pedagogics, law etc.).
- 9. Knowledge and co-creation of innovations and innovative professional approaches in a specific field of SW.
- 10. Skills of identification and management of one's own feelings and abilities to find help for oneself.
- 11. The ability to maintain and advocate professional autonomy of SW in dialogue with different actors, institutions and the public.
- 12. The ability to analyse social context and skills to protect sources and support integrative processes as well as the ability to co-create change in the community with the participation of the community.
- 13. Knowledge and skills for a joint analysis of needs, and planning and co-creation of adequate

services in a concrete field of SW.

- 14. Skills and knowledge to enable access to important sources and means, and the use of networks in any concrete field of SW.
- 15. The ability to argue and discuss as well as co-create the desired outcomes (such as solutions to problems) in a concrete field of SW.
- 16. Knowledge and ability to make first contact and establish a working relationship in the concrete field of SW.
- 17. Knowledge and ability to talk (develop relationships, negotiating, making agreements), conducting interviews towards the desired outcomes in a concrete field of SW.
- 18. Knowledge and ability of written recording and documenting in a concrete field of SW.
- 19. The ability to co-create approaches and methods of work in accordance with users' needs.
- 20. The ability of risk co-management in a concrete field of SW.
- 21. The ability to collaborate in supervision, intervision and other forms of support to one's own practice of social work within one's own learning group or in the field.
- 22. The ability of professional reflection of one's own practice in a concrete field of SW.
- 23. The ability to research and reflect on personal involvement in the procedures of SW.
- 24. The ability to realise the view and ethics of participation in the original projects of support and assistance in SW.
- 25. The ability of critical evaluation of the implications of the problems of culture, race, gender, age, difference in ability and sexual orientation for SW.
- 26. Autonomous realisation of individual tasks in the professional practice of SW.
- 27. The ability to take on the ethical and professional responsibility of being a social worker.
- 28. Use of research procedures and methods to conduct research.
- 29. Critical and self-critical judgement and evaluation of conducted research.
- 30. The ability to acquire new information, data analysis and the ability to interpret results.
- 31. The use of knowledge on the different types of approach to evaluation research to prepare an evaluation plan.

#### Enrolment conditions

The university study programme of Social Work is open to applicants who have passed the general matura examination or completed any four-year high school programme before June 1, 1995.

#### Selection Criteria in Restricted Enrolment

If a decision on restricted enrolment is adopted, the candidates will be selected in accordance with:

- their general success in the general matura examination or final examination: 60%
- general success in the 3rd and 4th years of high school 40%,

Criteria for the recognition of knowledge and skills acquired prior to enrolment in the programme

The higher education institution recognises informally acquired knowledge prior to the enrolment in the first year of the study programme of Social Work.

Procedure of identification, examination, certification and recognition of informally acquired knowledge and skills is the same for candidates who intend to enrol at the FSW and students already enrolled at the FSW.

Candidates who wish to have informally acquired knowledge and skills recognised as the fulfilled conditions for enrolment, or as a part of the requirements of the study programme in which they are already enrolled, can apply for the recognition procedure. The expression "candidate" is also applied for students, as appropriate.

The principles in the procedures of the recognition of informal knowledge and skills: Those informally acquired knowledge and skills are recognised by FSW, which in their content, extent and complexity entirely or in part meet the requirements for general or subject-specific competences defined by the study programme into which the candidate wants to enrol.

A certificate or other document for the completed programme which state the date and institution, the number of ECTS (if applicable) and the programme with the content that the candidate attended shall be considered grounds for recognition.

The informally acquired knowledge and skills of candidates shall be identified, examined, verified and recognised by the Undergraduate Study Committee.

#### Forms of examination

Forms of examination are compliant with the Statutes of the UL and stated in the study curricula.

# Conditions for progression within the programme

"Students can enrol in the higher year if they meet all the requirements of the study programme for the enrolment in the higher year until the end of the study year.

Conditions for progression to higher years of the study of social work include the passing of all exams from the previous year.

#### Enrolment in the higher year in exceptional circumstances

In exceptional circumstances students can be enrolled in the higher year, even if they did not meet all the requirements of the study programme for the enrolment in the higher year, when they have justified reasons for this and they meet the condition of the minimum amount of ECTS of the running year, which totals 40 ECTS. Possible justified reasons include the following, with proof provided with the adequate documentation:

- · parenting;
- · long-term illness;
- · exceptional family and social situation;
- · certified status of a person with special needs;
- · active co-operation in top professional, cultural and sports events;
- · active participation in the sense of holding elected offices in University

bodies.

The Student Affairs Committee decides on the enrolment from the previous

paragraph.

#### Repeating a year

Students who did not meet all the requirements defined by the study programme for enrolment in a higher year can repeat a year once during their study."

# Conditions for transferring between programmes

Compliant to the Criteria for Transferring between Study Programmes transferring is possible from study programmes which on completion of study guarantee the acquisition of comparable competences and among which at least half of the requirements, according to ECTS from the first study programme, which refer to compulsory subjects of the second study programme, can be recognised in accordance with the Criteria for the Recognition. Transferring from other programmes is possible after the completed first year of study.

The Senate of UL FSW shall decide on the possibility of transferring based on individual evidence on the fulfilment of the conditions according to the procedure and criteria defined by the Call for Enrolment and the Statutes of the UL.

### Conditions for the Completion of Study

Students complete the study when they meet all the requirements in the amount of 240 ECTS from the syllabus or the recognised requirements.

Conditions for the completion of sections of the programme, if they are its integral parts The study programme does not consist of individual sections.
