### 1 Information on Second cycle study programmes

In study year 2021/2022 Call for enrolment will be open for following study programmes:

- 1. Community mental health (part-time)
- 2. Social work with older people (part-time)
- 3. Social Work- full time

# 2 Admission requirements and the criteria for applicants' selection in the case of restricted enrolment

### Admission requirements

Completed:

- first-cycle study programme in the field of social work, sociology, social pedagogy, psychology or law involving acquisition of 240 credits or
- first-cycle study programme in another professional field involving 240 credits; previously the candidate must have passed differential examinations (25 credits), including three subjects of 4 credits each, and practical work amounting to 10 credits; subjects are: Methodology of Research in Social Work, Theories and Methods in Social Work, Contemporary Social Work in Slovenia and Social Work Practice; in accordance with Article 38 of the Higher Education Act, these obligations must be fulfilled prior to enrolment in the master's programme or
- three-year revised first-cycle study programme involving acquisition of 180 credits; the candidate must complete an extra year (Supplementary Programme) and thereby acquire the missing 60 credits or
- 4-year professional higher education programme in the fields set out in the first indent; the candidate may enrol in the master's programme under the conditions given in the first indent or
- 4-year professional higher education programme in another professional field; the candidate may enrol in the master's programme under the conditions given in the second indent or
- 3-year professional higher education programme; the candidate may enrol under the conditions given in the third indent.

Enrolment is also open to candidates who have completed equivalent education, defined in items 1. to 6. abroad. They can enrol under the same conditions as candidates who have completed education in Slovenia.

Certificates, diplomas and other qualifications issued outside Slovenia have to undergo recognition of foreign education. The equivalence of foreign education is determined in the procedure set by the Statute of the University of Ljubljana. The procedure must conclude before admission.

# Criteria for applicants' selection in the case of restricted enrolment:

Criteria for applicants' selection in the case of restricted enrolment in Master study programmes comprise:

Grade point average in previous studies – 100 % (graduation thesis grade is excluded).

### 2.1 Curriculum of the Supplementary Programme (60 ECTS)

Graduates from three-year Bachelor programmes must first (prior to enrolment in a Master programme) complete the one-year Supplementary Programme offered by the Faculty.

#### 2.2 Differential exams

Candidates that completed the first-cycle study programme in another professional field involving 240 credits; previously the candidate must have passed differential exams (25 credits), including three subjects of 5 credits each, and practical work amounting to 10 credits; subjects are:

- Methodology of Research in Social Work,
- Theories and Methods in Social Work,
- Contemporary Social Work in Slovenia and
- Social Work Practice.

In accordance with Article 38 of the Higher Education Act, these obligations must be fulfilled prior to enrolment in the master's programme.

Knowledge and skills acquired through formal, informal or experiential learning may be recognised as fulfilling certain requirements in the educational process. For their recognition the student can submit:

- Certificates of concluded courses, summer schools, or other forms of education
- Published articles or other authored works

Requests of recognition will be considered and assessed in credit points by the Committee for postgraduate studies

  - 2 The basic programme goals and competences achieved by the programme

### 2.1 The basic programme goals:

To introduce students to a comprehensive study of social work in the field of mental health within the community and to enhance and supplement their knowledge and skills acquired at the under-graduate level in order to improve the quality of community services working with people suffering from long-term mental distress; to provide students with a focused specialisation in specific areas of mental health within the community such as advocacy, individual planning, working with people in acute mental health crises and providing an internationally comparable skill set. The chief goal of this comprehensive programme is to give students a basic framework for under-standing the scope of the field and to introduce them to current policies and new forms of mental health efforts in the community at home and abroad as well as the processes accompanying those. At the same time, students also gain the ability to understand, critically evaluate and use various research methods in the field and they are equipped with the knowledge and methods for the critical evaluation of mental health practices within the community.

### 2.2 The student is qualified to:

### (General competences)

- critically assess modern theories and existing practices regarding mental health in the community,
- pursue autonomous professional community work with people with mental health difficulties,
- critically evaluate the existing mental health service in the community,
- plan and implement a practical innovative project based on evaluated needs,
- understand, critically evaluate and apply different methods of qualitative research,
- research together with users and other actors,
- understand gender and cultural issues in the context of mental health and anti-discriminatory principles,
- recognise and reflect on own prejudices,
- reflect on experiences during practical work and integrate theory and practice,
- introduce new knowledge to existing teams,
- apply relevant domestic and international resources,
- write scientific texts,
- cooperate in international scientific and practical work,

### (Subject-specific competences)

- be familiar with the socio-political dimensions of mental health in the community, its legal aspects and scope for development,
- know of new forms of social services in Slovenia and abroad and the socio-political and economic processes involved in them,
- know the characteristics and special features of the more prominent systems of ensuring social security services in European countries,
- know the functioning of mental health institutions,
- know the labelling processes,
- organise support in the community following release from an institution (special social institutions, hospitals etc.),
- know the concepts and method of individual planning, formulate an individual plan and assume an appropriate role in its fulfilment,
- know the legislation in the area of mental health and the methods of advocacy.
- master the skill of practising advocacy,
- assess risk and possess the skills to make a systematic and in-depth analysis of a risky situation,
- pursue interdisciplinary links between different experts and team work with the aim of jointly seeking appropriate solutions,
- critically analyse existing practices in handling the stories of users,
- describe a situation, conduct and record an interview and keep documentation according to the principles of good practice,
- understand the issue of mental health from the position of experiencing it,
- understand psychoanalytical theory and the links between mental and social processes,
- understand the processes and mechanisms of events in the group and know how to apply that knowledge in managing groups,
- know the methods and dynamics of prevention,
- evaluate services in terms of anti-discriminatory principles, make an action plan based on the evaluation and implement more sensitive practices.

### 2 The basic programme goals and competences achieved by the programme

### 2.1 The basic programme goals:

To guide students towards an in-depth and in-dependent study of social work with older people; to be able to work with the elderly requiring specialised social work in the community or in institutional care for older people and to be able to provide advice in preparing for old age to all generations that are just entering the aging pro-cess and to enable students to acquaint them-selves and understand contemporary theories and practices in social work with older people and their applications in specific practical work in these areas. This programme enables students to gain knowledge in working with people suffering from dementia and those needing long-term care at home or in any institutions for the care of older people. Graduates of the master's programme are educated based on practical work where they identify, analyse, seek solutions and develop innovative approaches to solving problems specific to old people in the spirit of social work.

### 2.2 The student is qualified to:

- analyse and synthesise knowledge of old age and ageing in modern society, envisage solutions and consequences of actions in social work with old people,
- master research methods in social work as well as procedures and processes in the area of social work with old people,
- develop critical and self-critical assessment,
- apply knowledge in practice,
- resolve the individual problems of old people arising in the community, institutions for old people and working environments in which older workers are employed,
- develop innovative programmes and methods of operation in social work with old people,
- perform professional work autonomously,
- develop skills in communication, public speaking and presenting opinions,
- reflect on ethics and be committed to professional ethics,
- be cooperative, work in a team or group and pursue community actions,
- make interdisciplinary links between different experts in the field of work with old people and coordinate the work of these experts with emphasis on accommodating the individual needs of the old person.

1.3 Number of credits (ECTS): 60 ECTS

### 2 The basic programme goals and competences achieved by the programme

### 2.1 The basic programme goals:

To enable students to acquire specific new skills for effective social work with families in a study process that repeatedly calls for the integration of concepts in work projects; to learn to provide support and assistance, enabling students to have a new work experience with families on two levels: building a working relationship that enables co-creation of original work projects for help and cooperation and through the exploration of changes that a family needs in order to achieve desired outcomes; to learn about specialised social work with families in various fields (e.g. divorce, foster care, etc.) and in various institutional contexts (e.g. social work centres, non-governmental organisations).

### 2.2 The student is qualified to:

- know and understand concepts, theories and phenomena as well as the methods and procedures of social work,
- analyse and synthesise knowledge of the family in modern society, since this enables a
  differentiated understanding of problems and is a cornerstone for co-creating viable solutions in
  social work with families,
- apply research methods in social work, and apply procedures and processes in the area of social work with families,
- think and act strategically,
- apply knowledge, procedures and methods in practice,
- apply critical and ethical self-reflection in thinking and actions,
- recognise, understand and respond to diversity,
- recognise and understand human hardships and crises tied to socially and personally determined circumstances.

- critically analyse social policy in terms of gender equality in practice,
- understand the historical development of ideas in social work,
- understand the development of the profession, institutions, methods and education in the field of social work,
- know the key figures and fundamental works in the field of social work in the 19th and 20th centuries.
- understand the differing development of social work around the world, with emphasis on the development of social work in Eastern Europe,
