GUIDE TO THE SECOND CYCLE STUDY PROGRAMMES At the University of Ljubljana, Faculty of social work

1 Information on Second cycle study programmes

In study year 2025/2026 Call for enrolment will be open for following study programmes:

- 1. Social Work full time
- 2. Social work with older people (part-time)
 - 2 Admission requirements and the criteria for applicants' selection in the case of restricted enrolment

Admission requirements

The second cycle Master's degree programme is open to students who have completed:

- (a) a study programme of at least first cycle, evaluated at least 240 credits, in the field of social work or an equivalent study programme obtained in accordance with the existing regulations in the Republic of Slovenia or abroad;
- b) a study programme of at least a first cycle attested by at least 240 credits in other professional fields or an equivalent study programme obtained in accordance with the previous regulations in the Republic of Slovenia or abroad, provided that the student has passed the differential examinations (30 credits) prior to enrolment, which includes 4 subjects of 5 credits and a Practicum of 10 credits. The subjects are: Contemporary Social Work in Slovenia, Theories and Methods in Social Work, Introduction to a Working Relationship of Co-creation, Methodology of Research in Social Work, and the Practicum. c) a study programme of at least a first cycle valid for at least 180 credits or an equivalent study programme obtained according to the previous regulations in the Republic of Slovenia or abroad, provided that the student has completed the study requirements of the additional year (Supplementary Programme) prior to enrolment.

Certificates, diplomas and other qualifications issued outside Slovenia have to undergo recognition of foreign education. The equivalence of foreign education is determined in the procedure set by the Statute of the University of Ljubljana. The procedure must conclude before admission.

Criteria for applicants' selection in the case of restricted enrolment:

If there are more candidates than available places, the candidates' undergraduate study achievement will be considered (the average grade excluding the grade of the graduation thesis).

Eligibility and selection criteria apply equally to the graduates of reformed (first-cycle) and to those of pre-reformed Bachelor programmes.

2.1 Curriculum of the Supplementary Programme (60 ECTS)

Graduates from three-year Bachelor programmes must first (prior to enrolment in a Master programme) complete the one-year **Supplementary Programme** offered by the Faculty.

2.2 Differential exams

Candidates that completed the first-cycle study programme in another professional field involving 240 credits; previously the candidate must have passed differential exams (30 credits), including four subjects of 5 credits each, and practical work amounting to 10 credits. Subjects are:

- Methodology of Research in Social Work,
- Theories and Methods in Social Work,
- Introduction to a working relationship of co-creation,
- Contemporary Social Work in Slovenia and
- Social Work Practice.

In accordance with Article 38 of the Higher Education Act, these obligations must be fulfilled prior to enrolment in the master's programme.

3 Recognition of other achievements

Knowledge and skills acquired through formal, informal or experiential learning may be recognized as fulfilling certain requirements in the educational process. For their recognition the student can submit:

- Certificates of concluded courses, summer schools, or other forms of education
- Published articles or other authored works
- Evidences of awards or prizes or nominations thereof
- Work certificates or evidences of practical experiences

Requests of recognition will be considered and assessed in credit points by the Committee for postgraduate studies

- 6 Sufficient: performance meets the minimum criteria
- 1-5 fail: performance does not meet the minimum criteria

Exams, seminar papers, projects can also be evaluated by pass/fail.

- 3. Social justice in social work critical perspective

- 6. Social work and interprofessional collaboration

At the enrolment the student chooses only one module.

2 The basic programme goals and competences achieved by the programme

2.1 The basic programme goals:

- 1. To enable students to get to know basic values, concepts, mandates, methods and theories of social work on the field of education.
- 2.To enable students to get to know basic skills, methods and procedures of social work and to be able to independently counsel in education, resaerch work in social work.
- 3. To enable students, through engaged cooperation in an action project, to create practical integration and/or synthesis of concepts, methods, skills and ethnic treatment.

2.2 The student is qualified to:

General competences (learning outcomes)

Students will acquire general competences through the study of compulsory subjects and through practical fieldwork and project work. These competences include:

1. knowledge and understanding

- The basic values, principles and skills of contemporary participatory social work,

- the theory, approaches and methods of contemporary participatory social work in the field of psychosocial support and assistance (counselling) and in the field of interprofessional and interinstitutional cooperation (teamwork)
- basic social science and humanistic theories and concepts that are key to social work,
- basic general knowledge of the different fields of social work.

2. Ability to synthesise

- of the fundamental concepts of contemporary participatory social work with the ways in which they can be implemented in direct and indirect social work practice,
- pedagogical, psychological, sociological, organisational knowledge into theories, methods and procedures of social work,
- knowledge and understanding of the legal, economic, (socio)political, organisational and cultural factors of people's life contexts and their implementation in social work practice,
- different theories into personal theoretical matrices and approaches, methods and techniques into a personal style of work or cooperation.

3. The use of

- language of contemporary participatory social work,
- methods and basic skills of participatory social work,
- theories and concepts to design an action (project), to understand the enabling conditions for the development of change processes and the desired outcomes of one's own work,
- the project-style of working,
- methods of social work in a practical setting.

4. Critical reflection (and consistent application of the ethics of participation, empowerment)

- the role of social work, the distribution of social power,
- the role of social policy in social work,
- the role of the social worker, taking into account the partnership role of the user as an expert by experience,
- their own conceptual assumptions, procedures and professional practices in the light of social and experiential dimensions,
- the contextualisation of one's own research or development project within legal, historical, political and organisational frameworks,
- their own participation in the project and the interaction between the researcher and the system being researched.

5. Ability of ethical conduct

- according to the Code of Ethics for Social Work,
- in a way that ensures ethical participation for all actors within the social work interaction,
- in the social security system,
- in terms of social and experiential dimensions,
- in the working environment and in interprofessional and interinstitutional cooperation,
- in a practical situation.

6. Ability to co-create innovative solutions to personal or collective distress, need for support and support at the level of

- the user system (individual, partnership, family, group, organisation, team, community) and their lifeworld,
- methods and procedures,
- the organisation of services,
- social security concepts and policies.

Subject-specific competences (learning outcomes)

Subject-specific competences are those related to the student's individual specialisation in terms of the choice of modules, electives and the production of the Master's thesis. These competences are:

1. knowledge and understanding

- the basic concepts and working (collaborative) approaches of contemporary social work in the fields of counselling in education, youth leisure, mental health and substance use, disability, ethnicity, migration and gender, psychosocial support and assistance to individuals and families, care of the elderly, interprofessional and inter-institutional cooperation, teamwork and management of a social welfare organisation,
- methods and techniques of group and team work in the different areas of social work covered by the programme,
- the developmental patterns, differences and needs of the individual,
- knowledge of and ability to apply contributions from other disciplines relevant to social work with families (psychological and sociological knowledge of the family, knowledge of family therapy, knowledge of team functioning);
- the social consequences of an ageing population and the attitudes of contemporary society towards older people,
- understanding and recognition of the principles of deinstitutionalisation, a system of care based on needs and rights, and the processes of coordinated care in the community,

- the power of users and their contribution to the creation of community services,
- contemporary theories of mental health and the community mental health system,
- the micro world of licit and illicit drug use,
- understanding the mechanisms by which the image of the other is constructed in mainstream society and institutional racism as a consequence;
- concepts of ethnicity, forced migration, racism, cultural diversity, globalisation and global (in)justice;
- the construction of borders and liminality, and the processes of exclusion of ethnic minorities and immigrants;
- the characteristics of traumatic experiences, the diversity of their consequences and the forms of assistance for people suffering from the acute and long-term consequences of traumatic experiences (with a focus on migration and abuse experiences in the private sphere and institutions);
- the functioning of institutions and the relationship between institutions and the social environment, looking at and working towards improving institutional practices in the field of social work, in selected areas: the protection and respect of children's rights and the voice and childhood of the child, the elderly, people with long-term mental health problems, drug users, disability, migration and gender, education and inter-professional and inter-institutional cooperation; the protection and respect of children's rights and the voice and childhood of the child,
- the historical development of social work methods and social welfare institutions,
- social science concepts of the sphere of life called leisure and its integration into the whole life-world of young people,
- the protection/risk factors in different selected areas of social work,
- values in social work and conflicts of values and their actual implications in social work practice,
- knowledge of critical research and evaluation methodologies used in social work,
- methods of acquiring and enhancing applied knowledge.

2. Ability to synthesise

- different research methods into practical research designs,
- theoretical doctrinal principles of social work with practical professional work in a chosen field of social work.
- psychological and pedagogical knowledge for working with children and adults in education.
- doctrines and concepts of social work in the field of unstructured time,
- contemporary concepts of cooperation in working relationships and original work projects (note-taking, talking, negotiating, organising support and assistance, etc.) with direct practice in selected areas of social work.

3. The use of:

- Basic concepts and working (collaborative) approaches of social work in direct practice in selected areas of social work,

- By acquiring general and subject-specific competences, social workers will be able to establish and maintain a working relationship with the family and confidently co-create original community-based work projects,
- the basic concepts and methods of inclusive education,
- the contemporary basic concepts of social work with older people in the different roles that social workers play in working with older people,
- skills in planning and implementing interventions and practical work in the field of drug use,
- methods such as needs assessment, personal planning, organisation and coordination of care in the community,
- methods of helping people suffering from the acute and long-term consequences of a traumatic experience,
- advocacy through a critical analysis of social developments and relations, learning the concepts and techniques of advocacy, the basic concepts and working (collaborative) approaches of participatory, project-based social work in an international context,
- qualitative research methods,
- critical research methods,
- action research methods,
- the ability to use ICT professionally and effectively in the search, selection, processing, presentation and communication of information.

4. Critical reflection (with consistent application of the ethics of participation, empowerment)

- the role of the researcher and their own research procedures,
- the role of the social worker in selected areas of social work as an expert in the dialogical and collaborative process of co-creating negotiated desired outcomes
- own conceptual assumptions, approaches, skills, resources, impact in the field of counselling in selected areas of social work,
- personal involvement in social work processes,
- own professional procedures and practices in social work practice in selected areas of social work.
- Autonomy, (self-)criticality, (self-)evaluation and the pursuit of quality and the defence of professional autonomy in social work in dialogue with different actors, institutions and the public,
- professional discourses (discursive or epistemological analysis) and their effects in the field of social work in education,
- the use of the language of social work and the development of a professional discipline for the refinement of forms of assistance and support to families as a co-creation of desired outcomes.

5. Ability for ethical conduct:

- in research,
- in specific selected areas of social work,

- in counselling, supervision and teaching interactions in the field of education,
- The ability to identify, reflect on and articulate the ethical dimensions of social work situations.
- self-reflection and critical analysis of one's own conduct and evaluation,
- towards promoting greater social openness to the inclusion of people with disabilities, ethnic minorities, refugees, people with mental health problems, the elderly and other stigmatised groups.

6. Ability to co-create innovative solutions

- in processes of protection (prevention) and empowerment of different (user and professional) systems in the context of different selected areas of social work,
- in original projects of support and assistance (counselling, planning, organisation and coordination of care, community work) in dialogue with different (user and professional) systems in the context of the chosen fields of social work,
- the ability to co-create original support and assistance projects in dialogue with adults and children in a way that allows all voices to be heard;
- in researching and applying research findings to innovate in practice,
- and the ability to understand innovation and development in social care and other sectors of the welfare state,
- through hypothesis and research question setting, designing research agendas in partnership with the systems being researched, through research
- by encouraging service users to do research.

Graduates of the Master's programme will thus be able to research, organise, analyse, co-create solutions and develop innovative approaches in practice in processes of learning, supporting, counselling or helping people in need in a specific, social work way, different from the approaches of other profiles dealing with people in need.

1.2 Programme duration: 1 year

1.3 Number of credits (ECTS): 60 ECTS

2 The basic programme goals and competences achieved by the programme

2.1 The basic programme goals:

To guide students towards an in-depth and in-dependent study of social work with older people; to be able to work with the elderly requiring specialised social work in the community or in institutional care for older people and to be able to provide advice in preparing for old age to all generations that are just entering the aging pro-cess and to enable students to acquaint them-selves and understand contemporary theories and practices in social work with older people and their applications in specific practical work in these areas. This programme enables students to gain knowledge in working with people suffering from dementia and those needing long-term care at home or in any institutions for the care of older people. Graduates of the master's programme are educated based on practical work where they identify, analyse, seek solutions and develop innovative approaches to solving problems specific to old people in the spirit of social work.

2.2 The student is qualified to:

General competences

- analyse and synthesise knowledge of old age and ageing in modern society, envisage solutions and consequences of actions in social work with old people,
- master research methods in social work as well as procedures and processes in the area of social work with old people,
- develop critical and self-critical assessment,
- apply knowledge in practice,
- resolve the individual problems of old people arising in the community, institutions for old people and working environments in which older workers are employed,
- develop innovative programmes and methods of operation in social work with old people,
- perform professional work autonomously,
- develop skills in communication, public speaking and presenting opinions,
- reflect on ethics and be committed to professional ethics,
- be cooperative, work in a team or group and pursue community actions,
- make interdisciplinary links between different experts in the field of work with old people and coordinate the work of these experts with emphasis on accommodating the individual needs of the old person.

Subject-specific competences

- knowledge to be able to research the position and role of old people in society,
- knowledge about the prejudice and discrimination against old people in contemporary society, which affects their position in the community and gives social work with old people a special role in the community,
- knowledge on the relevance and role of social work in institutions for old people,
- competence in research in the field of social work with old people, especially in the use of qualitative research methods,
- the ability to use research as a method of social work, enabling the design of innovative forms of work in the field of social work with old people,
- knowledge on the specific role of social work in the integrated care of people with dementia in their home environment and in institutions for old people,
- the ability to develop new, contemporary approaches to the care of people with dementia in the community and in institutions for old people,
- knowledge that would aim to reduce the impact of old people's homes as total institutions on the lives of their residents,
- knowledge and understanding of the risks of old age and ageing in contemporary society,
- the ability to use knowledge about the risks of old age as a challenge for innovative problem solving for old people,
- awareness of the importance of the living environment of old people,
- the ability to co-create an original working project to help an old person,
- the ability to co-create a conversation and take into account the unique life situation of an individual,
- knowledge on the processes of integration, inclusion and exclusion of old people in the community,
- the ability to promote, organise, plan and evaluate community action,
- knowledge and understanding of the legal framework associated with the situation of old people in Slovenia and internationally.

The graduates of the Master's programme will thus be able to identify, analyse, find solutions and develop innovative approaches to solving the problems of old people in a social work-specific way that differs from the approaches of other profiles dealing with people's distress.
