Razlogi za direktno socialno delo: odtujevanje socialnega dela od družbenih gibanj, uporabi birokratizaciji in ekonomizaciji socialnega dela in vsakdanjega življenja, neposredna akcija v situaciji ekonomskega izkoriščanja in življenjske negotovosti. Etika direktnega socialnega dela.

Kritika dobroteljnosti. Utemeljenost socialnega dela v gibanjih za družbeno pravičnost. Protislovja povezovanja socialnega dela s socialno državo. Radikalno socialno delo. Zasedbena gibanja in socialna vprašanja. Imperativ ne-izključevanja kot temelj neposredne demokracije. Direktna akcija in demokracija in socialno delo. Socialno delo v obdobju negotovosti.

Osi »dokapitalizacije ljudi«: stabilna socialna varnost in gotovost, obramba pred izžemanjem kapitalizma, ustvarjanje skupnosti.

Molekularna revolucija in kontrarevolucija.

Ethics of direct social work. Critique of charity. Movements for social justice as a historical base of social work.

Contradictions of social work engagement in welfare state. Radical social work.

Occupy movements and social issues.

Imperative of non-exclusion as a foundation of direct democracy. Direct action and democracy and social work. Social work in the age of precariat.

Axes of bailing out the people: stable social security and certainty, defence against exploitation of rampant capitalism, re-creation of the communities. Molecular revolution and counter-revolution.

Work of the social work. Principles of dialogue, transversality, advocacy, humour, Social work and ethical and esthetical paradigm. Spaces and registers of social work, modes of action.
